## **Hillcrest Commons**







#### **Project Overview**

Hillcrest Commons, located at 711 E. Tillman Road, will provide a permanent home for Fort Wayne's most vulnerable adults facing chronic homelessness. This project proposes the demolition of the vacant, blighted Hillcrest school so that new life may be brought to the site through the construction of multi-family, permanent supportive housing consisting of 24 one-bedroom units. Together, Fort Wayne Housing Authority, Parkview Behavioral Health Institute, and the Model Group hope to stabilize the lives of individuals and families struggling with homelessness.

An energy-efficient three-story apartment building will be developed that contains programmed community space with a kitchen, fitness room, lounges for meeting and recreating, common laundry facilities, and an office and conference room for on-site delivery of services. Amenities also include off-street parking and an outdoor courtyard with garden. Security features will include a single point of access, locked entry doors, interior and exterior cameras and lights, and on-site staffing. Additionally, FWHA's headquarters located adjacent to the project site will allow for easy and effective monitoring and maintenance of the building and grounds.

This project has widespread support from the City of Fort Wayne, the Corporation for Supportive Housing, Indiana Housing and Community Development Authority (IHCDA), and other local businesses and community groups.
